The AGAR was not accurately completed before submission for review.

- The figures in Section 2, Box 8 of the prior year comparative column do not agree to the prior year final signed AGAR. The Box 8 figure for the prior year was amended but the original figure was put into the 2020 column on the current year AGAR. Section 2, Box 8 for the prior year should read £86,914.
- Section 2, Box 10 is inconsistent with the balance published by the Public Works Loan Board. The figure in Box 10 should read £68,928. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR.
